



**ABSTRACT**

**ORDER:**

In Government order first read above, the Government have sanctioned a sum of Rs.89,84,00,000/- (Rupees Eighty nine crore eighty four lakh only) i.e.,Rs.67,38,00,000/- (Rupees Sixty seven crore thirty eight lakh only) being 75% of the Government of India grants-in-aid and Rs.22,46,00,000/- (Rupees Twenty two crore forty six lakh only) being 25% of State Share to upgrade the Adyar Cancer Institute as State Cancer Institute under the National Programme for Prevention and Control of Cancer, Diabetes, Cardio Vascular Disease and Stroke Program (NPCDCS) for the year of 2014-15, subject to the terms and conditions prescribed in Memorandum of Understanding (MoU) and also subject to the following terms;

- a) The recurring cost to be met by the Adyar Cancer Institute itself.(If any from new project)
- b) The extent of free treatment being given a relook, considering the huge investment afresh by Government of India/Government of Tamil Nadu.

2. The Chairman, Adyar Cancer Institute in her letter 2<sup>nd</sup> read above, among others, has requested to release the remaining State Share of Rs.25,54,00,000/- (Rupees Twenty Five Crores and Fifty Four lakhs only) for complete the procurement of the equipments to the Institute.

3. The Government have examined the request of the Chairman, Cancer Institute, Adyar in detail. In letter, dated 12.07.2018, the Government of India has mentioned that, 67.38 crore (60%) has been released by Government of India to Cancer Institute, Adyar in 2014-15. Further, based on the above release of the Government of India, the Government of Tamil Nadu has to release a corresponding share of Rs.44.92 crore, of which, the Government of Tamil Nadu have released Rs.22.46 crore already in G.O. 1<sup>st</sup> read above. The Government hereby accord sanction for a sum of Rs.22,46,00,000/- (Rupees Twenty two crore and forty six lakh only) of State Share for setting up State Cancer Institute at Cancer Institute, Adyar, Chennai under Tertiary Cancer Centre Scheme of National programme for prevention and control of Cancer, Diabetes, CVD and Stroke (NPCDCS) in 12<sup>th</sup> Five Year Plan (2012-17),subject to the terms and conditions prescribed in Memorandum of Understanding and in G.O(Ms).No.269, Health and Family Welfare (EAP II-I) Department,dated:03.09.2015.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of account:-

" 2210 Medical and Public Health – 80 General 800 Other Expenditure – State's Expenditure – AD Grants to Private Medical Institution under the Control of Director of Medical Education – 309 Grants-in-Aid-01 Grants for current Expenditure" ( DPC 2210-80-800-AD 0915) - Old.

(2210-80-800-AD 30901-IFHRMS).

5. Necessary additional funds of Rs.2246.00 lakhs will be provided in the RE / FMA 2019 – 20. Pending provision of such funds, the Director of Medical Education is authorized to draw and disburse the amount mentioned in para 3 above. However, this expenditure shall be brought to the notice of the legislature by Specific inclusion in the Supplementary Estimates 2019-20. The Director of Medical Education is also requested to include this expenditure while sending the budget proposals for RE / FMA 2019 – 20 and draft explanatory notes for Supplementary Estimates 2019 – 20 to Government in Finance (Health-II/BG-I) Department without fail.

6. This order issues with the concurrence of Finance Department vide its U.O.No.49114/Health-II/2019, dated:1.10.2019 and ASL No.1621 (One thousand six hundred and twenty one).
