### **ORDER:**

The Secretary, G.R.D. Educational Trust, Chennai has requested the Government to grant permission to start four years B.Pharm course in the name and style as "G.R.D. College of Pharmacy", Pudur Village, Thiruvallur with an annual intake of 60 seats from the academic year 2020-2021.

2. In Government letter fourth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed pharmacy college has fulfilled the conditions prescribed by the Government in the Government Orders first to third read above and as per the norms of the Pharmacy Council of India, New Delhi.

3. In his letter fifth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Pharmacy Council of India, New Delhi and recommended to grant permission to the Secretary, G.R.D. Educational Trust, Chennai to start four years B.Pharm course in the name and style as "G.R.D. College of Pharmacy", Pudur Village, Thiruvallur with an annual intake of 60 seats from the academic year 2020-2021.

4. The Government examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Secretary, G.R.D. Educational Trust, Chennai to start four years B.Pharm course in the name and style as "G.R.D. College of Pharmacy" with an annual intake of 60 seats in S.F. Nos.649/1B, 2, 651/1, 2C, 3, 4A, 4B, 5A, 636/1A, 611 and 680/8, Pudur Village, Thiruvallur-Thiruthani National Highways, Thiruvallur District – 631 210 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.148, Health and Family Welfare (PME) Department, dated: 24.04.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building completion certificate from the competent authority, i.e. PWD Engineer.
- ii. The Trust should obtain the affiliation from the Tamil Nadu Dr. M.G.R. Medical University to the above pharmacy institution.

5. The Director of Medical Education is directed to take necessary further action accordingly.
