ORDER:-

In the letter read above, the Director of Medical and Rural Health Services has stated that the Government Hospital, Villupuram is the third largest hospital in the district functioning with 100 sanctioned bed strength. An average of 1240 Out-Patient and 75 In-Patient are treated per day at this hospital. An average of 20 dental patients attends the hospital daily. Subsequent to the conversion of the erstwhile Government Headquarters Hospital as Medical College, Villupuram, the Government Taluk Hospital functioning in Villupuram is providing quality secondary care level treatments to the people living in and around Villupuram. The Government Hospital, Villupuram is functioning with Out-Patient department, Male ward, Female ward, Accident and Emergency ward and Eye ward etc., with operation theatre facility, but without a dental ward. In the absence of dental surgeon in the hospital, dental patients living in Villupuram have to travel to the Medical College Hospital.

2. The Director of Medical and Rural Health Services has requested the Government to accord sanction for the creation of one post of Assistant surgeon (Dental) (at an average cost of Rs.8,55,096/- per annum) along with the sanction for necessary equipments (at a total cost of Rs.2,34,888/-) for the dental ward to the Government Hospital, Villupuram .

3. The Government after careful examination of the proposal of Director of Medical and Rural Health Services, accord sanction for creation of one post of Assistant surgeon (Dental) in time Scale of Pay Rs.15600 - 39100 + G.P 5400 to the Government Hospital, Villupuram, Villupuram District at an average annual recurring cost of Rs.8,55,096/- (Rupees Eight Lakhs Fifty Five Thousand and Ninety Six only) for the period of one year from the date of filling up of the post

along with sanction for non-recurring expenditure of Rs.2,34,888/- (Rupees Two Lakhs Thirty Four Thousand Eight Hundred and Eighty Eight only) towards necessary equipments for the dental ward to the Government Hospital, Villupuram as detailed in the annexure to this order.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Accounts:-

“2210 - Medical and Public Health – 01-Urban Health Services - Allopathy- 110 – Hospitals and Dispensaries -- I Non - Plan AB Taluk Headquarters Hospitals - 01 Salaries”.

5. Necessary funds will be provided in Final Modified Appropriation 2015-16, pending provision of such funds in Final Modified Appropriation 2015-16, the Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned in para 3 above. The Director of Medical and Rural Health Services is requested to include this expenditure while sending the budget proposals for Final Modified Appropriation 2015-16 to Government in Finance (Health-II) Department without fail.

6. The Director of Medical and Rural Health Services is directed that the amount sanctioned for equipments shall not be paid in cash but credited to the following P.D. Account of Tamil Nadu Medical Services Corporation Limited:

“K Deposit and Advances (b) Deposits not bearing interest – 8443.00 – Civil Deposit – 800 – Other Deposits – CE Deposits of Tamil Nadu Medical Services Corporation Limited” (DPC 8443 00 800 CE 000H) (Receipts).

The Director of Medical and Rural Health Services is authorized to draw and deposit the amount sanctioned for equipments to the P.D. Account of Tamil Nadu Medical Services Corporation Limited, Chennai by means of Cheque / Demand Draft in favour of P.D. Account of the Managing Director, Tamil Nadu Medical Services Corporation Limited, Chennai.
