ORDER

In the Government Order first read above Government have issued orders appointing Tampcol as Nodal Agency for procurement and supply of all kinds of Indian System and Homoeopathy Medicines (Siddha, Ayurveda, Unani and Homoeopathy) instruments, Machineries and equipment requirements of all institutions functioning under the control of Commissioner of Indian Medicine and Homoeopathy and requirements of Siddha, Ayurveda, Unani and Homoeopathy medicines of other institutions functioning in the State, duly mentioning that the quantum of service charges to be paid to TAMPCOL shall be decided separately after verifying the actual expenses incurred by the Corporation at the end of the year for this purpose.

2. The Chairman and Managing Director, Tampcol has furnished the following details regarding the proposed transactions and expenditures of the Corporation's Nodal Agency activities during the financial year 2014-2015:

3. Further the Chairman and Managing Director, Tampcol has now requested administrative approval for constitution of a Sub-Committee for deciding the quantum of charges to be fixed for nodal agency activities of TAMPCOL, as suggested by the Government in the letter 3rd read above, with the following members:-

- i) General Manager, Tampcol.
- ii) Financial Adviser and Chief Accounts Officer, Office of the Commissioner of Indian Medicine and Homoeopathy.
- iii) Deputy Director from Finance (BPE) Department. (looking after Tampcol Subject)
- iv) Deputy Secretary / Under Secretary to Government, Health and Family Welfare Department.

After careful examination of the above proposal of the Chairman and Managing Director, TAMPCOL, the Government accord necessary administrative approval for constitution of a sub-committee with the following members, for recommending the quantum of charges to be fixed for Tampcol's nodal agency activities:-

- i) General Manager, Tampcol.
- ii) Financial Adviser and Chief Accounts Officer, Office of the Commissioner of Indian Medicine and Homoeopathy.
- iii) Thiru.C.R.Balaji, Deputy Director, Finance (BPE) Department. (looking after Tampcol subject)
- iv) Deputy Secretary / Under Secretary to Government, Health and Family Welfare Department.

The committee shall submit its report to the Government through the Chairman and Managing Director, TAMPCOL, Chennai within 3 months from the date of issue of this order.
