#### **ORDER:**

The Chairman and Secretary, Angammal Educational Trust, Elayampalayam, Tiruchengode, Namakkal District has requested the Government to grant permission to start four years Bachelor of Physiotherapy (BPT) course in the name and style as “Swamy Vivekanandha Physiotherapy College”, Unjanai, Elayampalayam, Tiruchengode, Namakkal District with an annual intake of 100 seats from the academic year 2020-2021.

2. In Government letter third read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed Physiotherapy College has fulfilled the conditions prescribed by the Government in the Government Orders first to second read above.

3. In his letter fourth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government and recommended to grant permission to the Chairman and Secretary, Angammal Educational Trust, Elayampalayam, Tiruchengode, Namakkal District to start four years Bachelor of Physiotherapy

(BPT) course in the name and style as "Swamy Vivekanandha Physiotherapy College", Unjanai, Elayampalayam, Tiruchengode, Namakkal District with an annual intake of 100 seats from the academic year 2020-2021.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. The Government hereby grant permission to the Chairman and Secretary, Angammal Educational Trust, Elayampalayam, Tiruchengode, Namakkal District to start four years Bachelor of Physiotherapy (BPT) course with an annual intake of 100 (hundred) students in the name and style as "Swamy Vivekanandha Physiotherapy College", in S.F. No.147/1B at Unjanai Village, Elayampalayam, Tiruchengode, Namakkal District – 637 205 from the academic year 2020-2021, subject to fulfill the following specific conditions along with other general conditions laid down in G.O (Ms) No.81, Health and Family Welfare (PME.2) Department, dated: 14.03.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building plan approval from the Directorate of Town and Country and Planning (DTCP).
- i. The Trust should obtain Clearance Certificate from the Tamil Nadu Pollution Control Board, Namakkal.
- ii. The Trust should obtain affiliation from the Tamil Nadu Dr. M.G.R. Medical University, Chennai.
