ORDER:

The Mission Director, National Health Mission in his letter read above, has stated that, the Reproductive Child Health Centre of Excellence were included in PIP 2017-18 and PIP 2018 -19, in order to provide Quality service, to strengthen the Reproductive Child Health Centre in District Head Quarters Hospitals at Dindigul, Thiruvallur, Krishnagiri, Nilgiris and Sub-District Hospital at Mayiladuthurai which was also approved in ROP 2017-18 and 2018-19 and the Civil works for the Maternity and Child Health Wings was already commenced and nearing completion as per the orders issued in G.O(Ms)No.88, Health and Family Welfare (EAP II-I) department, dated:15.3.2018 and G.O(Ms)No.345, Health and Family Welfare (EAP II-I) department, dated: 10.8.2019. The details are as follows:-

2. The Mission Director, National Health Mission has further stated that, the bed strength increased, the placement of additional Obstetricians and Gynaecologists, Anaesthetists, Paediatricians and the Staff Nurses are necessary to give Quality care to the patients and necessary proposals was approved in PIP 2019-20. As the bed occupancy rate is higher during the times of epidemic, the placement of additional Human Resources in the above said 5 institutions becomes necessary to give Quality care to the patients without interruption. He added that, by appointing the additional Human Resources, it will be useful in monitoring high risk mothers to track Higher Order of Birth (HOB) Mothers, Ante - Natal and Post - Natal mothers will be benefited by getting good patient care. Based on the delivery load, the Mission Director has

furnished the requirement of Obstetrician and Gynaecologist, Paediatrician, Anaesthetist, Staff Nurse and Sanitary Worker as follows:

The Mission Director, National Health Mission has further stated that, the posts of the specialists are sanctioned in the cadre of Assistant Surgeon in District Head Quarters Hospitals / Sub-District Hospital as per Government of Tamil Nadu norms. Regular time scale pay for posts of Specialist and Staff Nurse Salary will be remitted into State treasury as per National Health Mission norms. The Cadre controlling officer will be Director of Medical and Rural Health Services. The above proposal has been approved in RoP 2019 – 20 and in 37th EC meeting held on 11.02.2019. He has stated that, the total financial commitment involved in this proposal to the State Government is Rs.9,15,76,800/- per annum (approximately). The Mission Director, National Health Mission has requested necessary orders in this regard.

5. The Government have examined the proposal of the Mission Director, National Health Mission in detail and decided to accept the same and accordingly issue the following orders:

- (i) Sanction is accorded for creation of 152 posts to Maternity and Child Health Wings in District Head Quarters Hospitals at Dindigul, Thiruvallur, Krishnagiri, Udagamandalam and Sub-District Hospital at Mayiladuthurai, as detailed below:-

(ii) Out of the above 152 posts, 80 posts of Staff Nurse created in the ratio of 2:1 as per G.O(Ms)No.400, Health and Family Welfare Department, dated: 16.12.2014 (i.e) 27 post created under Regular time scale of pay and 53 post created under contract pay.

(iii) The Mission Director, National Health Mission/Joint Director Health Services, concerned is directed to fill up the Multipurpose Hospital Worker posts through outsourcing by following existing procedure and they will not be absorbed into Government service (time scale of pay) in future.
