National Health Mission - Strengthening of CEmONC centres – Sanction of 161 posts of Assistant Professor, Staff Nurses (Regular and Contract) and Multipurpose Hospital Workers to 6 Medical College Hospitals under National Health Mission as per ROP approval 2019-2020 – Administration Sanction - Orders issued.

ORDER:

The Mission Director, National Health Mission in his letter read above, has stated that, the strengthening of CEmONC Centres proposal was included in PIP 2017-18 and PIP 2018 -19, in order to provide Quality service, to strengthen the Reproductive Child Health Centre in Chengalpet, Vellore, Thiruvanamalai, Theni, Thiruvarur, Villupuram Medical College Hospitals which was also approved in RoP 2017 -18 and 2018-19. Further, the civil works for the above CeMoNC centres was already commenced and in progress as per the orders issued in G.O(Ms)No.365, Health and Family Welfare department, dated 13.10.2017 and G.O(Ms)No.321, Health and Family Welfare department, dated:1.8.2018 as detailed below:

2. Further, the Mission Director, National Health Mission has stated that, the bed strength has increased, the placement of additional Obstetrician and Gynaecologists, Anaesthetists, Paediatricians and the Staff Nurses are necessary to give Quality care to the patients and hence, to strengthen the centers with adequate Human Resources necessary proposals was placed in PIP 19 -20 and the same was approved. As the bed occupancy rate is higher during the times of epidemic, the placement of additional Human Resources in the above said 6 institutions becomes

necessary to give Quality care to the patients without interruption due to high case loads. He added that, by appointing the additional Human Resources it will be useful in monitoring high risk mothers, to track Higher Order-Birth (HOB) Mothers, Ante Natal and Pre Natal mothers will be benefited by getting good patient care and this reduces MMR. Further he has furnished the requirement of Human Resources as follows:-

3. The Mission Director, National Health Mission has further stated that, as per National Health Mission norms, the consolidated pay approved in ROP will be reimbursed to State Government for those Medical Officers and time scale pay Staff Nurse who will draw time scale pay without any additional expenditure to be incurred to Government and the Cadre controlling officer will be Director of Medical Education. The above proposal was placed and approved in RoP 2019-20 and in 37th EC meeting held on 11.2.2019. The Mission Director, National Health Mission has requested the Government to issue necessary orders in this regard.

4. The Government have examined the proposal of the Mission Director, National Health Mission and decided to accept the same and accordingly issue the following orders:

- (i) The Mission Director, National Health Mission is requested to examine the possibilities for increase the percentage of expenditure met for salaries at other CeMoNC centres in Headquarters Hospitals and Medical College Hospitals under National Health Mission funding.
- (ii) Sanction is accorded for creation of 161 posts to the CeMoNC wings in the six Government Medical College Hospitals at Chengalpet, Theni, Vellore, Villupuram, Thiruvapur and Thiruvannamalai as detailed in the annexure to this order.
- (iii) The Mission Director, National Health Mission is permitted to incur the expenditure for the above activity from National Health Mission approved funds.
- (iv) The Mission Director, National Health Mission is directed to remit the salary of the posts sanctioned in regular pay from the amount approved under NHM into the State Government as per the existing procedure.
- (v) Out of the above 161 posts, 100 post of Staff Nurses created in ratio of 2:1 as per G.O(Ms)No.400, Health and Family Welfare (AA1) Department, dated: 16.12.2014. Hence, 33 post created under Regular time scale of pay and 67 post created under contract pay.

(vi) The Mission Director, National Health Mission / the Dean concerned is directed that, the Multipurpose Hospital Worker post to be filled up through outsourcing and they should not be absorbed into Government service (time scale of pay) in future.
