ORDER:

In Government Order fourth read above, permission was accorded to the Karpagam Charity Trust, Coimbatore to start the College of Nursing in the name and style as "Karpagam Nursing College" at Othakkalmandapam

Village, Coimbatore District to conduct B.Sc (Nursing) course with an annual intake of 50 students from the academic year 2007-2008.

2. The Principal, Karpagam Nursing College run by Karpagam Charity Trust, Coimbatore has requested the Government to grant permission to enhance the seats in B.Sc (Nursing) course from 50 to 100 from the academic year 2020-2021 to the above institution.

3. In Government letter eighth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to third and fifth to seventh read above and as per the norms of the Indian Nursing Council, New Delhi.

4. In his letter ninth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommended to grant permission to the Principal, Karpagam Nursing College at Othakkalmandapam Village, Coimbatore District run by Karpagam Charity Trust, Coimbatore to enhance the seats in B.Sc Nursing course from 50 to 100 to the above institution.

5. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Principal, Karpagam Nursing College at Othakkalmandapam Village, Coimbatore District run by Karpagam Charity Trust, Coimbatore to enhance the seats in B.Sc Nursing course from 50 to 100 (fifty to hundred) at Karpagam Nursing College in Survey.Nos.636/1A, 637/1A, 763/1A, 763/1B, 763/1C, 763/2, 764/2, 770/2B, 770/2C and 770/2D, Othakkalmandapam Village, Madukkarai Taluk, Coimbatore -641 032, subject to fulfill the specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should construct the remaining academic block in 2nd floor is 14,154 Sq.ft and hostel block is 25,042 sq.ft within a period of 3 months as mentioned in the undertaking submitted by the Trust.
- ii. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

6. The Director of Medical Education is directed to take necessary further action accordingly.
