ORDER:

In Government Order fourth read above, permission was accorded to the Managing Trustee, Savariar Educational Trust, Karuppur, Marudhanallur Post, Thippirajapuram, Kumbakonam Taluk, Thanjavur District to start a College of Nursing in the name and style as "St. Xavier College of Nursing" to conduct B.Sc Nursing Course at Kumbakonam, Thanjavur District with an annual intake of 50 students from the academic year 2010-2011.

2. The Correspondent, St. Xavier College of Nursing, Sakkottai, Kumbakonam Taluk, Thanjavur District run by Savariar Educational Trust, Karuppur, Marudhanallur Post, Thippirajapuram, Kumbakonam Taluk, Thanjavur District has requested the Government to grant permission to enhance the seats in B.Sc Nursing course from 50 to 100 to the above institution.

3. In Government letter eighth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing school has fulfilled the conditions prescribed by the Government in the Government Orders first to third and fifth to seventh read above and as per the norms of the Indian Nursing Council, New Delhi.

4. In his letter nineth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommended to grant permission to the Correspondent, St. Xavier College of Nursing, Sakkottai, Kumbakonam Taluk, Thanjavur District run by Savariar Educational Trust, Karuppur, Marudhanallur Post, Thippirajapuram, Kumbakonam Taluk, Thanjavur District to enhance the seats in B.Sc Nursing course from 50 to 100 to the above institution.

5. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. The Government hereby grant permission to the Correspondent, St. Xavier College of Nursing, Sakkottai, Kumbakonam Taluk, Thanjavur District run by Savariar Educational Trust, Karuppur, Marudhanallur Post, Thippirajapuram, Kumbakonam Taluk, Thanjavur District to enhance the seats in B.Sc Nursing course from 50 to 100 (fifty to hundred) at St. Xavier College of Nursing in R.S.No.72/3, Needamangalam Main Road, Sakkottai Village, Kumbakonam -612 401 subject to fulfill the specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building plan approval from the Directorate of Town and Country and Planning (DTCP).
- ii. The Trust should increase the bed strength of own parent hospital from 150 to 300 within a period of 3 years as mentioned in the undertaking submitted by the Trust.

- iii. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

6. The Director of Medical Education is directed to take necessary further action accordingly.
