As the vehicle requires huge amount for renovation, it would not be economical to incur huge expenditure to make the said aged vehicle roadworthy, the Technical Committee, Condemnation Board, and the Director of Medical Education have recommended for premature condemnation of the above said vehicle.

3. The Government, after careful examination, have decided to accept the proposal of the Director of Medical Education. Accordingly the Government hereby issue orders for the premature condemnation of the vehicle as detailed below:-
