ORDER:-

The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has sent draft Prospectus, Application and Notification for Admission to BSMS/BAMS/BNYS/BUMS/BHMS courses for the academic year 2015-2016, for approval of the Government.

2. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has requested orders of the Government to pursue the selection process for the present academic year and for granting approval on the following points:

- a. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy may be permitted to follow the same procedure for the selection of candidates 2015-16 session as was done in the academic year 2014-15 through Single Window counselling.
- b. To arrive the General Merit List for all the following Degree Courses BSMS/BAMS/BNYS/BUMS/BHMS
- c. To conduct the counseling for the spot selection for each of Degree Courses directly without arriving the selection / waiting list.

- d. To allot the colleges according to the merit of the marks obtained by the candidates and their option.
- e. Necessary orders may be issued for the selection of Special Category candidates for BSMS/BAMS/BNYS/BUMS/BHMS courses 2015-2016 session as follows:

i) Eminent Sportsman quota:

The process of selection will be followed through a Common Committee of experts in the field of sport as Constituted by the Government.

ii) Physically challenged:

The selection process under this quota will be made on par with Allopathy side. Physically Disabled candidates (Only Locomotor disorder) should produce a Certificate from the Medical Board (District Level Board of authorities concerned) with permissible percentage of 50% to 70% and in case candidates not available in that category then candidates with disability or lower limbs between 40% to 50% may be considered.

iii) +2 Siddha Subjects:

In the Special Category, 5 seats earmarked for students who have taken " Siddha" as one of the subject in the Higher Secondary Course. Admission to the BSMS course to such students under the Special category is made based on the marks obtained in Academic Marks in Science Subjects + Siddha Subject Marks.

- iv) The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy may be permitted to implement horizontal wise reservation as laid down in G.O.(Ms.) No. 198 / Higher Education Dept. dated 30-05-2003.
- v) The Rule of Reservation is being followed for all courses namely BSMS/BAMS/BNYS/BHMS. In case of BUMS the candidates available are from BC (Muslim) Community alone. Hence, the seats reserved for BC, MBC / DC, SC, and SC (Arunthathiyars) could not be filled up. Therefore permission may kindly be accorded to fillup the, unfilled BC seats only by BC Muslims and unfilled MBC/DNC, SC,SCA seats by thrown open to a OC (i.e. both BC and Non B.C. Muslim) if no BC, MBC/DC, SC, SC (Arunthathiyar) candidates available.

- vi) The permission may be accorded to adopt the Rule of Reservation as follows:

- f. The minimum eligibility marks for admission to BSMS/ BAMS/ BNYS/ BUMS/ BHMS courses may be fixed as follows as per Central Council of Indian Medicine Norms. "12th standard with science or any other equivalent examination recognized by University or Boards with **fifty percent aggregate marks** in the subjects of Physics, Chemistry and Biology or Botany and Zoology taken together."
- g. In respect of BUMS course in addition to the above qualification the following clause may be incorporated under education qualification as per Central Council of Indian Medicine Norms;

"to clear the test of Urdu in the Entrance Examination conducted by the University or Board or Registered Society authorized by the Government to conduct such examination"

For this academic year, the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy may be permitted to conduct the 10th standard level Urdu examination in consultation the Director of Government Examination and the expenditure in this regard shall be met from the Personal Deposit account.

3. The Government approve the Prospectus, Application form and Notification for admission of candidates in the Government / Self financing Indian System of Medicine Colleges to BSMS/BAMS/BNYS/BUMS/BHMS under graduate degree courses for the academic year 2015-2016. An approved copy of the prospectus, Application Form and notification is enclosed.

4. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy is permitted follow the procedure detailed in para 2 of this order in the selection process for the academic year 2015-2016.
