In Government Order second read above, administrative sanction was accorded for the implementation of Tamil Nadu Urban Healthcare Project at a cost of Rs.1634,69,50,000/- with the assistance of Japanese International Co-operation Agency (JICA). The Project Director, Tamil Nadu Urban Healthcare Project was permitted to establish TNUHC Society to implement the project in 21 Urban Towns/ Cities in 17 Districts of Tamil Nadu.

2. In the Government Order first read above, sanction was accorded for the creation of Project Management Unit for Tamil Nadu Urban Healthcare Project. The Project Management Unit of Tamil Nadu Urban Health Care Society is functioning in the Tamil Nadu Health Systems Project building (Director of Medical and Rural Health Services Annex).

Now the Project Director, Tamil Nadu Urban Healthcare Project has requested approval for repairs and renovations to Tamil Nadu Health Systems Project building at a cost of Rs.42.00 lakh for Civil works and Rs.35.25 lakh for Electrical work to be carried out through Public Works Department and sanction of Rs.10.00 lakh

towards procurement of furniture by the Project Director to be purchased through Public Works Department / TANSI.

4. The above proposal was placed before the State Empowered Committee during their first meeting held on 27.01.2018 and approved by the State Empowered Committee.

5. The Government after careful examination, permit the Project Director, Tamil Nadu Urban Health Care Project to do repairs and renovations to Tamil Nadu Health Systems Project building at a cost of Rs.42.00 lakh for Civil works and Rs.35.25 lakh for Electrical works which are to be carried out through Public Works Department and to procure furniture at a cost of Rs.10.00 lakh through Public Works Department /TANSI.
