ORDER:

In the G.O first read above, certain new posts viz. Reader / Professor and Tutor / Assistant Professor were created for the new Medical Colleges started in the State. In the said Government Order, it has been clarified that if the sufficient faculties are not available either by promotion or by direct recruitment, the posts shall be filled up on contract basis with consolidated pay.

2. In the G.O second read above, the Government have issued orders permitting the Director of Medical Education to fill up 25% of the vacancies in the post of Reader / Professor in all Government Medical Colleges on a consolidated pay as mentioned below, in addition to pension, by following the procedure prescribed in G.O.(Ms).No.333, Health and Family Welfare Department, dated 28.09.2004.

3. In the G.O third read above, the Government have enhanced the consolidated pay of retired Professors in Radiology Department from Rs.35,000/- to Rs.50,000/- per month with effect from the date of issue of the Order.

4. Subsequently, in the G.O. fourth read above, the Government have issued orders enhancing the consolidated amount of the retired faculties appointed on contract basis besides pension for a period of five years under the control of the Director of Medical Education for certain specialities in the Clinical and Non-Clinical areas mentioned therein from Rs.50,000/- to Rs. 70,000/- per month.

5. In her letter fifth read above, the Director of Medical Education has stated among others that the willingness of the retired Medical Officers have been called for in their directorate and so far no retired Medical Officers were furnished their willingness for the contract appointment. The demand for the retired Associate Professors / Professors in the Non Clinical and other scarce department is very high and hence the private Medical Colleges are offering attractive salary. There is a dearth of teaching personnel in the cadre of Associate Professor / Professor in all Non clinical Departments and in some Clinical Departments declared as scarce. As there is a need for more number of Associate Professor / Professor, it is necessary to appoint the retired Associate Professors / Professors on contract basis on consolidated pay besides regular promotees from the Tamil Nadu Medical Service to fulfill the Medical Council of India norms and welfare of the public. Finally, she has requested the Government to issue necessary orders to enhance the consolidated pay from Rs.70,000/- to Rs. 1,25,000/- and to reappoint the Medical Officers who are due for retirement on attaining the age of superannuation in all non-clinical and in some clinical departments declared as scarce on contract basis instead of obtaining willingness for the contract appointment.

6. The Government have examined the proposal of the Director of Medical Education and decided to enhance the consolidated pay of the retired Medical Officers who are appointed on contract basis from Rs.70,000/- to Rs.90,000/- per month besides pension in Clinical and Non-Clinical specialities mentioned in the G.O.fourth read above. Further, if the Medical Officers are appointed on contract basis after their retirement in the departments mentioned in the G.O.fourth read

above without getting their willingness, which is against the rule of law and therefore it has been decided to follow the procedures laid down in G.O. first read above for appointment of the Medical Officers on contract basis in the specialities mentioned in the G.O.fourth read above by taking into account of General Rule 11 of Tamil Nadu State and Subordinate Services. The Government accordingly do and hereby direct that the consolidated pay for the Medical Officers who are appointed on contract basis in the specialities mentioned in the G.O.fourth read above be enhanced from Rs.70,000/- to Rs.90,000/-(Rupees Ninety Thousand Only) besides pension. The Government also direct that the procedures laid down in the G.O.first read above for appointment of the Medical Officers on contract basis in the specialities mentioned in the G.O.fourth read above be followed by taking into account of General Rule 11 of Tamil Nadu State and Subordinate Services.
