The Director of Public Health and Preventive Medicine, in his letter 2nd read above has stated that the Dean, Shri Sathya Sai Medical College and Research Institute, Thiruporur, Kancheepuram District has submitted application seeking permission to have tie-up arrangements with Primary Health Centres at Sembakkam, Sirukundram and Ottivakkam in Saidapet Health Unit District during the academic year 2015-2016 for field practice by their MBBS, CRR I and PG students and has requested necessary orders in this regard.

The Government, after careful examination of the request of the Dean, Shri Sathya Sai Medical College and Research Institute, Thiruporur, Kancheepuram District along with the recommendation of the Director of Public Health and Preventive Medicine, have decided to accept the same and grant permission to the Dean, Shri Sathya Sai Medical College and Research Institute, Thiruporur, Kancheepuram District to have tie-up arrangements with the Primary Health Centres at Sembakkam, Sirukundram and Ottivakkam in Saidapet Health Unit District for a period of three years from the academic year 2015 – 2016 for field practice by their MBBS, CRR I and PG students, subject to the following conditions:

- i) The field visit should not be detrimental to the normal functioning of those Primary Health Centres;
- ii) The students should be deputed in small batches;
- iii) The Institution should pay the fees prescribed as per G.O (D) No.1258, Health and Family Welfare Department, Dated: 20.11.2014.

3. The Director of Public Health and Preventive Medicine is directed to take necessary action accordingly.
