### **ORDER:-**

In the Government Order first read above, the Government have accorded administrative and financial sanction for the construction of 4800 quarters at various places throughout the State and the construction of quarters for 1-Sub Inspector and 14-Police Constables /Head Constables for Kairulabath Police Station in S.F No.602, Ariyalur District is one among them.

2. The Director General of Police, Tamil Nadu in the letter second read above has stated that the Superintendent of Police, Ariyalur District has requested to construct quarters for 1-Sub Inspector and 14-Police Constables /Head Constables for Kairulabath Police Station at S.F No.344/5 at Thelur Village near new Kairulabath Police Station instead of S.F.No.602 in Ariyalur District, since Kairulabath Police Station is being constructed at Thelur Village in S.F No.344/5. The Chief Engineer, Tamil Nadu

Police Housing Corporation Limited has also informed that the above land is feasible for the construction of above said quarters.

3. The Director General of Police, Tamil Nadu, Chennai has therefore requested the Government to accord necessary administrative orders to construct quarters for 1-Sub Inspector and 14-Police Constables /Head Constables for Kairulabath Police Station in S.F No.344/5 at Thelur Village near new Kairulabath Police Station instead of S.F.No.602 in Ariyalur District.

4. The Government after detailed examination have decided to accept the proposal of the Director General of Police, Tamil Nadu. Accordingly, the Government accord permission for construction of quarters for 1-Sub Inspector and 14-Police Constables /Head Constables for Kairulabath Police Station in S.F No.344/5 at Thelur Village near new Kairulabath Police Station instead of S.F.No.602 in Ariyalur District subject to condition that the expenditure should be incurred within the amount sanctioned in the Government Order first read above and further request for sanction of any additional funds in this regard will not be entertained.
