ORDER:

The Hon'ble Chief Minister of Tamil Nadu, during the Police demand No.22, for the year 2021-2022,in the Tamil Nadu Legislative Assembly on 13.09.2021 has among others, made the following Announcement:-

- 2. Based on the above Announcement, the Director General of Police, Tamil Nadu in the letter read above has sent the following suggestions to the Government for implementation:
 - i) Further action may be dropped in all Punishment Rolls initiated under rule 3(a) of Tamil Nadu Police Subordinate Services (Discipline & Appeal) Rules, which are pending for passing orders as on 13.09.2021.
 - ii) Further action may be dropped in all Punishment Rolls which have been initiated under rule 3(a) of Tamil Nadu Police Subordinate Services (Discipline & Appeal) Rules, for which the punishment awarded is in currency as on 13.09.2021.

- iii) Since the cancellation of the punishment is a onetime welfare measure than on merits, it will have only prospective effect.
- iv) The beneficiaries of the above order shall not be eligible for retrospective claims for promotion /monetary benefits etc.
- v) The concerned Disciplinary Authority may be authorized to dispose the Punishment Rolls which have been issued under rule 3(a) of Tamil Nadu Police Subordinate Services (Discipline & Appeal) Rules, as per the orders of the Government to be issued in this regard.
- 3. The Government after taking into consideration of the suggestions of the Director General of Police and order as follows:
 - i) Further action may be dropped in all Punishment Rolls initiated under rule 3(a) of Tamil Nadu Police Subordinate Services (Discipline & Appeal) Rules, which are pending for passing orders as on 13.09.2021.
 - ii) Further action may be dropped in all Punishment Rolls which has been initiated under rule 3(a) of Tamil Nadu Police Subordinate Services (Discipline & Appeal) Rules, for which the punishment awarded is in currency as on 13.09.2021.
 - iii) The above cancellation of the punishment is a one time welfare measure for police personnel than on merits. It will have only prospective effect.
 - iv) The beneficiaries of the above order shall not be eligible for retrospective claims for promotion /monetary benefits, etc.
 - v) If the minor punishment imposed under rule 3(a) of the Tamil Nadu Police Subordinate Services (Discipline & Appeal) Rules, cancelled as on 13.09.2021 falls within the check period of a panel and stood as a bar for inclusion in the panel, the cases of such candidates shall be examined separately on a case to case basis for inclusion in the respective panels.
 - vi) If the minor punishment imposed under rule 3(a) of the Tamil Nadu Police Subordinate Services (Discipline & Appeal) Rules, which was completed prior to 13.09.2021 and falls within the check period of a panel and stood as a bar for inclusion in the panel, the cases of such candidates shall be examined separately on a case to case basis for inclusion in the respective panels.

- vii) The Disciplinary Authority concerned is authorized to dispose the Punishment Rolls which have been issued under rule 3(a) of Tamil Nadu Police Subordinate Services (Discipline & Appeal) Rules.
- 4. The Director General of Police, Tamil Nadu is directed to issue necessary instructions to all the concerned Disciplinary/Appellate authorities in this regard.
