ORDER:-

In the Government of India letter first read above, it has been stated that the "The Commercial Courts, Commercial Division and Commercial Appellate Division of High Courts Ordinance, 2015" has been promulgated on 23.10.2015 and that the Ordinance, inter-alia, provides for the constitution of Commercial Division and Commercial Appellate Division in the High Courts for adjudicating commercial disputes of specified value. Consequently, in the letter second read above, the Registrar General, High Court of Madras has forwarded the draft notification for designating the Court of Principal District Judges / District Judges heading the concerned Judicial Districts and court of Principal Judge, City Civil Court, Chennai as Commercial Courts and requested the Government to issue notification orders and to cause the same published in the Tamil Nadu Government Gazette.

2. The Government accepted the proposal of the Registrar General, High Court of Madras. Accordingly, the following notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION

In exercise of the powers conferred by section 3 of the Commercial Courts, Commercial Division and Commercial Appellate Division of High Courts Act, 2015 (Central Act 4 of 2016), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby constitutes one Commercial Court in each Judicial District in the State of Tamil Nadu, except city of Chennai, specifies the entire territorial limits of the Judicial District as the local limits of the area to which the jurisdiction of the respective Commercial Court shall extend and also appoints the Principal District Judge / District Judge of that Judicial District as the Judge of the respective Commercial Court.
