ORDER:

In Government Order first read above, the Government has directed Tamil Nadu Infrastructure Fund Management Corporation to register Tamil Nadu Shelter Fund (Tier-II Component of Shelter Fund) as Category-I Social Alternate Investment Fund with Securities and Exchange Board of India (SEBI).

2. In the letter second read above, the Chief Executive Officer, Tamil Nadu Infrastructure Fund Management Corporation Limited has stated that,

- i. As part of the structure of the Fund, Tamil Nadu Infrastructure Fund Management Corporation Limited had appointed an independent Investment Committee which would approve, monitor and review exits of the investments made from the Fund.
- ii. The Board of Tamil Nadu Infrastructure Fund Management Corporation Limited, in its circular resolution BM CR 4/2018-19 has accorded for approval of the formation of Investment Committee-Tamil Nadu Shelter Fund on 25.10.2018 with the following members:-
 - a) Mr. Azmat Taufique
 - b) Mr. Arun Ramanathan
 - c) Mr. S. Mahalingam
 - d) Mr. V. Somasundaram and
 - e) Dr. N. Sundaradevan

- iii. Subsequently, the Board of Tamil Nadu Infrastructure Fund Management Corporation Limited in its circular resolution CR 05/2021-22 dated 11.03.2022 has accorded for reconstituted the Investment Committee-Tamil Nadu Shelter Fund with the following members:-
- a) Mr. Arun Ramanathan
 - b) Mr. S. Mahalingam
 - c) Dr. N. Sundaradevan
- iv. Further, to the resignation of Mr. Arun Ramanathan, the Board inducted Dr. P.Jayapal as a Member of the Investment committee. The Board reconstituted the Investment Committee-Tamil Nadu Shelter Fund with the following Members with effect from May 20, 2022:-
- a) Mr. S. Mahalingam
 - b) Dr. N. Sundaradevan
 - c) Dr. P. Jayapal
- v. As per the Securities and Exchange Board of India (Alternative Investment Funds) (Amendment) Regulations, 2020, the approval of 75% of investors the value of their investment in the Fund is required to formalise the appointment of the external members to the Investment Committee.
