ORDER:

In the Government Order first read above, Notification declaring the intention of the Government to add certain additional areas to the Hosur New Town Development Area under clause (c) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), was issued.

2. In the Government Order second read above, Hosur New Town Development Area was declared under sub-section (4) of section 10 of the said Act.

3. In the Government order third read above, Government have issued orders for the constitution of Hosur Urban Development Authority as an adhoc body, an Advisory Council for the purpose of advising the Hosur Urban Development Authority on the formulation and co-ordination of plans for the development of Hosur Planning Area and a Planning Cell for initiating specific plans and projects for Urban Development.

4. Subsequently, the Government have made amendment to the said Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) vide the Tamil Nadu Town and Country Planning (Second Amendment) Act, 2022 (Tamil Nadu Act 38 of 2022), among others, to specify certain Planning Area and to constitute Urban Development Authority. The said Amendment Act, 2022 has come into force with effect on the 14.09.2022.

5. Based on the report of Member Secretary / Deputy Director, Hosur New Town Development Authority, in the letter fourth read above, the Director of Town and Country Planning has requested the Government to notify the area of 1071.79 Sq.Km covering 91 revenue villages in Hosur Taluk, 19 revenue villages in Shoolagiri Taluk and 59 revenue villages in Denkanikottai Taluk (totally 169 revenue villages) as Hosur Urban Planning Area under the said section 2(48) the Tamil Nadu Act, 1971 as inserted vide the said Amendment Act, 2022.

6. The Government, after careful consideration of the proposal of the Director of Town and Country Planning have decided to notify the area 1071.79 Sq.Km covering 91 revenue villages in Hosur Taluk, 19 revenue villages in Shoolagiri Taluk and 59 revenue villages in Denkanikottai Taluk (totally 169 revenue villages) specified in the Notification appended to this Order as Hosur Urban Planning Area under the said section 2(48) of the said Act and order accordingly.

7. The appended Notification will be published in the Tamil Nadu Government Gazette.

8. The Collector of Krishnagiri is directed to republish the Notification in the District Gazette.

9. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Works Manager, Government Central Press for publication of the same in the Tamil Nadu Government Gazette and also to the Collector of Krishnagiri District under intimation to the Government.

10. The Collector of Krishnagiri District is directed to report to Government the date of republication of the notification in the District Gazette.
