## ORDER:

The Hon'ble Minister Public Works, Highways and Minor Ports Department has made the following announcement on 12.04.2022 on the floor of the Assembly during the Budget demand of Highways and Minor Ports Department for the year 2022-2023.

- 2. In the Government Order first read above, the Government have accorded Administrative Sanction at a cost of Rs.15,42,00,000/- for the work of "Construction of Foot Over Bridge with Escalator at Km 14/8 of Inner Ring Road at Temple School junction (SH-02)".
- 3. In the letter second read above, the Chief Engineer (H), Metro has stated that it was inferred that, there is a proposal of Under Ground station at the said location (at Km 14/8 of IRR road, near Temple School) under Phase-2, Corridor-5 by the CMRL Ltd., Chennai. In this regard, clarification was sought from CMRL and the CMRL has informed that they are constructing an Under Ground Kolathur Metro station at Temple School junction with facilities of lift, Escalator and staircase on both sides of IRR Carriageway and it will have unpaid access for pedestrian movement for crossing the Inner Ring Road and access to the station and the CMRL has also shared the Concourse level plan and Ground level plan at this junction.

- 4. The Chief Engineer (H), Metro has also stated that, an additional facility by Highways Department by way of providing FOB with escalator at the same location will duplicate the facility and may result in loss to the Government.
- 5. The Chief Engineer (H), Metro has therefore requested the Government for deleting the work sanctioned for a sum of Rs.15,42,00,000/- for the "Construction of Foot Over Bridge with Escalator at Km 14/8 of Inner Ring Road at Temple School junction in Chennai (SH-02)" in G.O.(Ms).No.168, Highways and Minor Ports (HW2) Department, Dated: 25.08.2022.
- 6. The Government after careful examination, accept the proposal of the Chief Engineer (H), Metro and accord orders for deleting the work of "Construction of Foot Over Bridge with Escalator at Km 14/8 of Inner Ring Road at Temple School junction in Chennai (SH-02)" in G.O.(Ms).No.168, Highways and Minor Ports (HW2) Department, Dated: 25.08.2022.
