ORDER:-

In pursuance of the executive orders issued in the Government Order second read above, the Government now issue amendments to the Service Rules of Poompohar Shipping Corporation Limited.

2) The following notification shall be published in the Tamil Nadu Government Gazette.

NOTIFICATION.

In exercise of the powers conferred under section 13(B) of the Industrial Employment (Standing orders) Act, 1946 (Central Act XX of 1946), the Governor of Tamil Nadu hereby makes the following amendment to the Service Rules of the Poompohar Shipping Corporation Limited, Madras.

2) This amendment hereby made shall be deemed to have come into force with effect from 16.11.2018.

AMENDMENTS.

In the said Rules, in chapter II under Rule 2.22 (a), the following shall be substituted:-

“Every Staff / Officer of the Corporation EXCEPT Office Assistant / Sweeper shall retire from service on the afternoon of the last day of the month in which he/she

attains the age of fifty eight years. Office Assistants and Sweepers of the Corporation shall retire on attaining the age of sixty years."
