ORDER

In the Government Order first read above, the minimum rates of wages for the employment in Tailoring Industry were revised under the provisions of the Minimum Wages Act, 1948 (Central Act XI of 1948). In the Government Order second read above, a Preliminary Notification was issued in order to further revise the minimum rates of wages for the said employment in Tailoring Industry.

2. The Commissioner of Labour, in his letter third read above, has stated that objections and suggestions were received from the persons likely to be affected by such revision and which were placed in the State Advisory Board and was decided to confirm the said Preliminary Notification without any modification. Hence he has requested the Government to confirm the above said Preliminary Notification.

3. The Government have now decided to confirm the orders issued in the Preliminary Notification.

4. The appended Notification will, accordingly, be published in the Tamil Nadu Government Gazette both in English and Tamil. The Secretary to Government, Tamil Development and Information Department, Secretariat, Chennai-600 009 is requested to send the Tamil translation of the Notification to the Works Manager, Government Central Press, Chennai-600 079. The Works Manager, Government Central Press, Chennai-600 079 is requested to publish the Notification and send five copies of the Gazette to the Government and the Commissioner of Labour for reference and record.
