ORDER:

The Vice chancellor, Tamil Nadu National Law School, Tiruchirappalli, in the Letter read above, among others, has stated that in view of implementation of 7th Pay Commission, the pay and allowances for the non-teaching staff have to be revised and the pay and allowances to the teaching staff as notified by the UGC has also to be revised after the necessary orders are issued by the Government. The Vice chancellor has further stated that, once Tamil Nadu National Law School proceeds with the recruitment of staff for teaching and non-teaching posts on regular/permanent basis, there will be financial recurring commitment towards payment of salary and allowances, which will pose a financial challenge. Therefore, the Vice chancellor has requested the Government to consider for sanction of Rupees Four Crore to meet out the short fall expenditure under payment of salary and allowances to the staff as the Tamil Nadu National Law School was not getting any grants from the Government of India/UGC, so far.

2. The Government, after careful consideration, taking into account the financial position of the Tamil Nadu National Law School, decided to accept the request of the Vice Chancellor, Tamil Nadu National Law School. Accordingly, Government sanction a sum of Rs.4,00,00,000/- (Rupees Four Crore only) for the year 2018-2019 as an adhoc grant to meet out the expected short fall expenditure under payment of salary and allowances to its staff subject to the condition that if the surplus position continues in future the possible repayment of the amount sanctioned may be explored by the Tamil Nadu National Law School.

3. The grant sanctioned in para 2 above shall be debited to the following head of account:-

"2202.General Education - 03.University and Higher Education - 102. Assistance to Universities - State's Expenditure - BO. National Law School, Tiruchy - 09. Grants-in-Aid - 01. Grants for Current Expenditure

4. Necessary additional funds of Rs.4,00,00,000/- will be provided in RE/FMA 2018-2019. Pending provision of such funds, the Director of Legal Studies, Chennai is authorized to draw and disburse the amount sanctioned in para 2 above. However the above expenditure shall be brought to the notice of the Legislative Assembly by Specific inclusion in Supplementary Estimate. The Director of Legal Studies, Chennai is also request to send necessary draft explanatory notes to the Government in Finance (BG-I/Home-II) Department for the specific inclusion of the above expenditure in the Supplementary Estimate RE/FMA for the year 2018-2019 at an appropriate time without fail.

5. The Director of Legal Studies, Chennai, is authorized to draw and disburse the amount sanctioned in para 2 above to the Tamil Nadu National Law School, Tiruchirappalli.

6. This order issues with the concurrence of Finance Department Vide its U.O. No.29118/Home-II/2018, dated 20.06.2018 and with ASL No.439 (Four hundred and thirty nine).


