ORDER:

In the Government Order first read above, it has been ordered that the apportionment of surcharge on stamp duty should be done based on the report of the Inspector General of Registration.

2. In the letter second read above, the Commissioner of Town Panchayats has stated that, the Inspector General of Registration had furnished the details of surcharge on Stamp Duty to be released to the Town Panchayats and to the Tamil Nadu Urban Road Infrastructure Fund (TURIF) for the quarter ending 31.12.2021 as follows:-

3. The CTP has requested the Government to accord sanction for the release of **Rs.25,73,64,885/- (Rupees Twenty Five Crore Seventy Three Lakhs Sixty Four Thousand Eight Hundred and Eighty Five only)** towards the release of Surcharge on Stamp Duty to Tamil Nadu Urban Road Infrastructure Fund (TURIF) and also to accord sanction for the release of **Rs.25,73,64,885/- (Rupees Twenty Five Crore Seventy Three Lakhs Sixty Four Thousand Eight Hundred and Eighty Five only)** towards the release of Surcharge on Stamp Duty to Town Panchayats for the quarter ending **31.12.2021**.

4. Based on the report of the Inspector General of Registration and as per the proposal of the Commissioner of Town Panchayats, the Government hereby accord, **(i)** Sanction for the release of a sum of **Rs.25,73,64,885/- (Rupees Twenty Five Crore Seventy Three Lakhs Sixty Four Thousand Eight Hundred and Eighty Five only)** towards the release of Surcharge on Stamp Duty to Tamil Nadu Urban Road Infrastructure Fund (TURIF) for the quarter ending 31.12.2022.

The above Expenditure shall be debited to the following head of account:-

"3604 - 00 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions - 200 Other Miscellaneous Compensations and Assignments - State's Expenditure-BI Contribution to Tamil Nadu Urban Road Infrastructure Fund (TURIF) from Assigned Revenue - Stamp Duty (DTP) - 310. Contributions 01 Contribution to Specific Fund"

(ii) Sanction is also accorded for the release of a sum of **Rs.25,73,64,885/- (Rupees Twenty Five Crore Seventy Three Lakhs Sixty Four Thousand Eight Hundred and Eighty Five only)** towards the release of Surcharge on Stamp Duty to Town Panchayats for the quarter ending 31.12.2021. The above Expenditure shall be debited to the following head of account:-

"3604 - 00 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions - 200 other Miscellaneous Compensations and Assignments - State's Expenditure - BJ Sharing of Assigned Revenue - Stamp Duty (DTP) - 309 Grants-in-aid 09 Others".

The Commissioner of Town Panchayats is authorized to draw and disburse the amount to the Town Panchayats and to the Tamil Nadu Urban Road Infrastructure Fund (TURIF) operated by the Chairman and Managing Director, TNUIFSL, the fund manager, subject to the condition that the amount so drawn should not exceed the amount of collection received from

the Inspector General of Registration. The Commissioner of Town Panchayats is also requested to adhere the instructions issued in G.O.(Ms).No.64, Municipal Administration and Water Supply (Election) Department, dated 28.02.2011.
