ORDER:

In the G.O first read above, orders were issued for the institution of the Hon'ble Chief Minister's Award for the best performing 3 Town Panchayats with a cash award of Rs.10.00 lakh, Rs.5.00 lakh and Rs.3.00 lakh respectively along with a citation in delivering essential services like drinking water supplies, formation of roads, street light maintenance, Public health and Solid Waste Management and the awards would be presented on the occasion of Independence Day by the Hon'ble Chief Minister. The Government also approved the criteria as suggested by the Commissioner of Town Panchayats to select the best performing 3 Town Panchayats and also constituted Committees at District and State Level.

2. In the G.O. second read above, an amendment have been issued to the Government Order first read above for the selection of best performing 3 Town Panchayats, based on the Eight Parameters suggested by the Tamil Nadu Institute of Urban Studies (TNIUS) ie., Water Supply, Financial Management, Solid Waste Management, Sanitation, Street Lights, Public Health, Poverty Alleviation and Special Initiatives and also deleting the District Level Committee constituted.

3. In the letter third read above, the Commissioner of Town Panchayats has sent the proposal for the continuance of the Scheme and requested the Government to release a sum of Rs.18.00 lakh for awarding the best 3 Town Panchayats for the year 2022 - 2023.

4. The Government, after careful examination, accept the proposal of the Commissioner of Town Panchayats and release a sum of Rs.18,00,000/- (Rupees Eighteen lakh only) towards the presentation of the Hon'ble Chief Minister's Award to the best performing 3 Town Panchayats for the year 2022 - 2023.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-
