In G.O.Ms. No.23, P&D (SPC) Department, dated:23.04.2020 orders on replacement of the State Planning Commission by the State Development Policy Council entrusting with Goal setting, Monitoring, Evaluation and Policy Advocacy, Creation of Policy Coherence and Implementation of Special Programmes have been issued. SDG is also part of the work entrusted to the State Development Policy Council.

6. Accordingly, Government hereby cancel the orders issued on diversion of posts from the State Development Policy Council formerly State Planning Commission to the Sustainable Development Goals Co-ordination Centre in the Government order first read above.
