Order:

In the Government Order read above, Government have sanctioned a sum of Rs.50,93,800/- (Rupees Fifty lakh Ninety Three thousand and Eight hundred only) towards the purchase of new vehicles in lieu of the condemned vehicles to Eight District Planning Cells. Accordingly, the procurement process has been initiated in GeM portal by the State Planning Commission. Due to the increase in vehicle cost, transportation charges for various places with GST, the District Planning Officers (Eight District Planning Cells) have requested additional fund and sent Quotations for the purchase of New vehicles for a sum of Rs.54,31,364/- (Rupees Fifty Four lakh Thirty One thousand Three hundred and Sixty Four only).

2. The proposal of Member Secretary, State Planning Commission towards the sanction of an additional amount of Rs.3,37,564/- (Rupees Three lakh Thirty Seven thousand Five hundred and Sixty Four only) for the purchase of above said vehicles has been examined in detail.

3. Government after careful examination hereby sanction an additional amount of Rs.3,37,564/- (Rupees Three Lakh Thirty Seven Thousand Five Hundred and Sixty Four only) towards additional requirement for the purchase of new vehicles in lieu of the condemned vehicles to the Eight District Planning Cells ordered vide Government Order first read above.

The Member Secretary, State Planning Commission is requested to include the above expenditure while sending proposals for Revised Estimate / Final Modified Appropriation 2019-2020 to the Government in Finance (Public) Department without fail.
