ORDER:

In the Government Order first read above orders have been issued for conduct of Panel Survey on Socio Economic of Elderly Population in Tamil Nadu in collaboration with J-PAL, SA with a total project cost of Rs.606.00 lakhs for the period of three years (Rs.90.00 lakhs+Rs.254.01 lakhs+Rs.261.99 lakhs) under Tamil Nadu Innovation Initiatives (TANII) and for the year 2015-16, an amount of Rs.90.00 lakhs has been released, of which Rs.9.97 lakhs has been allotted to Department of Economics and Statistics and Rs.80.02 lakhs has been allotted and released to J-PAL towards Technical Advisory Service and quality control costs.

2. The Principal Secretary/ Commissioner, Department of Economics and Statistics in his letter second read above has requested to release an amount of Rs.254.01 lakhs for the second phase of the project for the year 2016-17, to carry out the training of field staff, Baseline survey, procurement of Hardware and Software for data collection and workshops.

3. The Government after careful consideration accept the proposal of the Principal Secretary/Commissioner, Department of Economics and Statistics and accord sanction to release an amount of Rs. 254.01 lakhs (Rupees Two crore fifty four lakh and one thousand only) for the second phase of the project for the year 2016-17, to carry out the training of field staff, Baseline survey, procurement of Hardware and software for data collection and workshops. The Principal Secretary/Commissioner, Department of Economics and Statistics is authorized to draw and disburse the above sanctioned amount.
