ORDER:

Based on the announcement made under Rule 110 of Tamil Nadu Legislative Assembly on 19-07-2017, the Chennai Metro Rail Limited (CMRL), in coordination with KfW (German Development Bank) awarded the study of preparation of "Feasibility and Detailed Project Report for Mass Rapid Transit System (MRTS) in Coimbatore" to the Consortium of M/s. SYSTRA and M/s. RITES Ltd.

2. In the reference read above, the Managing Director, CMRL has informed that the Feasibility Report submitted by the Consultant firm has been approved by the Government, based on the decisions taken in the high level meeting held under the chairmanship of Additional Chief Secretary (Finance) on 02-02-2021. In this connection, the Managing Director, Chennai Metro Rail Limited has requested the Government to issue necessary orders for undertaking the preparation of the Detailed Project Report (DPR) for establishing a Mass Rapid Transit System (MRTS) for Coimbatore city.

The Government, after careful examination, have accepted the proposal of the Managing Director, Chennai Metro Rail Limited (CMRL) and permit CMRL to continue to pursue the preparation of Detailed Project Report (DPR) for establishing a Mass Rapid Transit System (MRTS) for Coimbatore city, with the funding already tied up from KfW, (the German Funding Agency).

4. The Government also direct that the concern of Avinashi Road Elevated Corridor Project shall also be taken into consideration while preparing the DPR for the Mass Rapid Transit System (MRTS) for Coimbatore city.

5. The Managing Director, Chennai Metro Rail Limited shall send a detailed report to Government on the progress in preparation in DPR for Coimbatore city on a monthly basis.
