ORDER:

In Government Order read above orders have been issued for the High Level Coordination Committee (HLCC) on Crop Estimation Survey (CES) and State Level Coordination Committee (SLCC) on Annual Survey of Industries (ASI) were merged with State Statistical Committee (SSC) under the Chairmanship of Vice-Chairman, State Planning Commission with Special Commissioner and Director, Department of Economics and Statistics, Chennai as Convener. The State Statistical Committee has to conduct a meeting on Crop Estimation Survey once in a year and a meeting on Annual Survey of Industries twice in a year.

2. The Additional Director General, National Sample Survey Office, Ministry of Statistics & Programme Implementation, New Delhi in his letter second read above has suggested to form two small size committees one each for discussing High Level Coordination Committee on Crop Estimation Survey and State Level Coordination Committee (SLCC) on Annual Survey of Industries under the Chairmanship of the Head of the Department of Economics and Statistics, the Joint Director of Statistics as Convener with Deputy Director General, National Sample Survey Office, Regional Office, Chennai-6 Member who would provide all assistance to these two Committees.

3. The Principal Secretary/Commissioner, Department of Economics and Statistics in his letter third read above has stated that the meeting of the State Statistical Committee (SSC) have not taken place as specified in the above Government Order due to various overriding priorities and preoccupation of the top level authorities. Therefore, he has requested the Government to issue orders for formation of two Committees High Level Coordination Committee (HLCC) on Crop Estimation Survey (CES) and State Level Coordination Committee (SLCC) on Annual Survey of Industries (ASI).

4. The Government accordingly decided for formation of two committees viz., High Level Coordination Committee (HLCC) on Crop Estimation Survey (CES) and State Level Coordination Committee (SLCC) on Annual Survey of Industries (ASI) under the Chairmanship of Principal Secretary/Commissioner, Department of Economics and Statistics, Chennai-6 as follows:-
