ORDER:

In the Government Order first read above, orders were issued revising the format for writing Annual Confidential Report in respect of State Service Officers (Group A and B) into single format as in the Annexure -I to the above said order. Orders were also issued on the guidelines to be followed in this regard as given in the Annexure - II to the said order.

2. In the reference second read above, the Secretary to Government , Human Resources Department inter-alia has observed that the 2 tier system for writing Annual Confidential Reports followed in some of the Departments is leading to difficulties at critical stages and requested to issue orders by concerned administrative department for writing Annual Confidential Reports of State Service Officers of Group A and B in the Heads of Department in the

P.T.O

prescribed 3-tier architecture specified as Reporting Reviewing and Accepting authority.

3. Accordingly, the Government hereby prescribe the Reporting / Reviewing / Accepting Authorities for Writing Annual Confidential Reports of State Service Officers (Group A and Group B) in respect of Heads of Department under the administrative control of Planning and Development Department as follows:-
