The Draft 4(1) Notification under urgency provision of Section 17(2) of the Land Acquisition Act 1894,(Central Act I of 1894) submitted by the Special Commissioner and Commissioner of Land Administration, Chennai for the construction of anicut across Malattar river for an extent of 17.44.5 hectares in S.No.278/1B etc., with his letter third read above is approved and will be published in the extra ordinary issue of the Tamil Nadu Government Gazette and in two Tamil Daily Newspapers circulating in the locality.
