### ORDER:

The Chief Engineer (Buildings) has stated that the existing Circuit house at Dharmapuri was constructed in the year 1979 with 3 suites on the ground floor. Subsequently, additional 3 suites were added on the first floor in the year 2003. As several V.I.P's and senior officers visit the district on official work and also enroute their visit to Bangalore, it is proposed to upgrade the infrastructure and other facilities in the Circuit house at Dharmapuri. According to Chief Engineer (Buildings), it is proposed to relay the flooring with ceramic tiles and dadoing the walls with glazed tiles, to replace the old worn-out furniture, curtains, bed spreads and water purifier besides carrying out special repairs to water supply and sanitary arrangements. Air conditioners are also proposed to be installed in all suites. Hence the Chief Engineer (Buildings) has requested the approval of the Government for the proposal of improvements to the Circuit House at Dharmapuri at an estimate of Rs.19.20 lakhs.

2. The above proposal was placed before the Standing Finance Committee and the Standing Finance Committee has also approved the proposal under Part II Scheme for 2008-2009.

3. The Government accordingly accord administrative sanction for a sum of Rs.19.20 lakhs (Rupees Nineteen lakhs and twenty thousand only) for the improvements to Circuit house at Dharmapuri in Dharmapuri District by relaying the floor with ceramic tiles, replacement to worn out furniture and furnishing etc., under Part II Scheme for the year 2008-2009, subject to the condition that the provision for petty supervision charges, contingencies and other unforeseen items together should not be exceeded the 2.5% cost of works.

4. The expenditure sanctioned in para 3 above shall be debitible to the following head of account.
