ORDER:

The Chief Engineer (Buildings) has stated that the office of Construction and Maintenance Sub Division at Ponneri is now functioning in a rented building. The construction and maintenance of all Government Buildings are being undertaken by this Sub Division. To provide proper working environment, it is essential to have the department's own building for this Sub Division with minimum basic amenities. Hence, he has proposed for construction of Sub Division office with one section office at Ponneri in Tiruvallur District at an estimated cost of Rs.15.00 lakhs and he has also stated that the estimate is prepared by adopting schedule rates for 2008-2009. The Chief Engineer (Buildings) has therefore requested the administrative sanction of the Government for the above work.

2. The above proposal was placed before the Standing Finance Committee and the Standing Finance Committee has also approved the proposal under Part II Schemes for 2008-2009.

3. Accordingly, the Government accord administrative sanction for a sum of Rs.15.00 lakhs (Rupees Fifteen lakhs only) for construction of Sub Division office with one section office at Ponneri in Tiruvallur District under Part II scheme for the year 2008-2009.

4. The expenditure sanctioned in para 2 above shall be debitable to the following head of account.

4059 capital outlay on Public Works – 01 Office Buildings 051 – Construction scheme in the Eleventh Five Year Plan II State Plan – JJ Public Works 16 Major Works (DPC 4059-01-051-JJ 1605).

5. The Chief Engineer (Building), Public Works Department is authorised to incur the expenditure as per the existing procedure. The estimate furnished by the Chief Engineer (Buildings) in his letter 3<sup>rd</sup> read above is approved.
