### ORDER:

The Engineer-In-Chief, Water Resources Organisation and Chief Engineer (General), Public Works Department, in his letters read above, has stated that the work of reconstruction of bridge (single lane bridge - I.R.C class AA loading) was proposed in the place of existing dilapidated foot bridge at mile 26-5-420 of Lower Bhavani Main Canal situated across the road of Nadupalayam to Molapalayam at Kurumandur Village of Gopichettipalayam Taluk. He has added that by implementing this scheme, the public and students would be greatly benefited as this is the only access available to go to the nearby town of Gopichettipalayam. He has also stated that this scheme does not require land acquisition and the total cost of the scheme works out to Rs.60.00 lakhs based on the schedule of rates for the year 2007-2008 and requested administrative sanction of the Government.

2) The Government after careful consideration, accept the proposal of the Engineer-in-Chief, Water Resources Organisation and Chief Engineer (General), Public Works Department and accord administrative sanction for the work of reconstruction of bridge at Mile 26-5-420 of Lower Bhavani Project Main Canal in Kurumandur Village, Gopichettipalayam Taluk of Erode District at an estimate cost of Rs.60.00 Lakhs (Rupees sixty lakhs only).

3) The expenditure sanctioned in para 2 above shall be debited under the following New sub head of account :-

“4701 Capital out lay on Major and Medium Irrigation 03. Medium Irrigation - 361 Commercial Lower Bhavani Project - Schemes in the Eleventh Five Year Plan-II State Plan – JA Lower Bhavani Project – 16. Major works (D.P.Code 4701-03-361 JA 1605)

4) The expenditure sanctioned in paragraph 2 above, constitutes an item of "New Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure shall initially be met by drawal of an advance from the Contingency Fund, orders regarding which will be issued from the Finance(BG.I) Department, separately. The Engineer-In-Chief, Water Resources Organisation and Chief Engineer (General), Public Works Department, is directed to send an application in the prescribed format for the sanction of an advance from the Contingency fund for the required amount, to the Government in Finance (BG.I) Department together with a copy of this order. He is also requested to send necessary explanatory notes to Finance (Public Works-II) Department for inclusion of the above expenditure in the Final Supplementary Estimates for the year 2007-2008, at the appropriate time without fail.

5) The Engineer-In-Chief, Water Resources Organisation and Chief Engineer (General), Public Works Department, is directed that, the lumpsum provisions for P.S. charges and unforeseen item together should not exceed 2.5% of the total cost of works and the provision for variation of quantity rates are disallowed under this project.

6) The Engineer-In-Chief, Water Resources Organisation & Chief Engineer(General), Public Works Department is the Estimating, Reconciling and Controlling Authority of the above new minor sub Head of Account. The Pay and Accounts Officer /Treasury Officers are requested to open the above sub Head of Account in their accounts.

7) This order issues with concurrence of Finance Department vide its U.O.No. 733/PWII/08, dated : 11.01.2008 and Additional Sanction Ledger No.1665 (one thousand six hundred and sixty five)
