ORDER:-

The Chief Engineer (Plan Formulation), Water Resources Department has sent the estimate for the work of Excavation of Supply Channel from Viruppampatti Tank to Balethottam Tank and Four Other Tanks and One Pond in Pochampalli Taluk of Krishnagiri District for an amount of Rs.1.75 crore based on the schedule of rates 2010-2011 along with provision for escalation for the year 2011-2012 and he has requested to accord administrative sanction for the same under NABARD loan assistance in RIDF XVII. This proposal has been forwarded to NABARD for loan assistance.

2. In the letter first read above the Chief Engineer (Plan Formulation), Water Resources Department has stated that the Nedungal anicut has been constructed across River Pennaiyar, downstream of Krishnagiri Reservoir. At the left side of the anicut a supply channel takes off to feed Barur Big Tank. Barur Big Tank has two main supply canals namely, Barur Tank East Main Canal and Barur Tank West Main Canal, Viruppampatti Tank is the tail end tank of Barur Tank East Main Canal. This scheme contemplates the excavation of supply canal from Viruppampatti tank to feed Balethottam tank and four other tanks and one pond in Pochampalli Taluk of Krishnagiri District for utilizing the flood surplus of River Pennaiyar. The surplus water proposed to be utilized is 5.28Mcft and the number of supply days are 7 and the discharge capacity of the canal is 8.73 Cusecs and the registered Ayacut under 5 tanks and one pond is 118 acres. In addition, 59 acres will be benefited by means of ground water recharge of the wells located in the zone of influence of tanks. Further 30 acres will be benefited along the canal alignment. Hence in total 207 acres (118+59+30) will be benefited by implementation of this scheme. An extent of 23 acres of patta land and 5.50 acres of poramboke land are to be acquired for this

scheme. The patta land owner has already been given their consent letter for Land Acquisition.

3. The following components are proposed in estimate:-

1. Excavation of Main canal for a length of 2.90 Kms.
2. Excavation of Branch canals to feed the tanks and pond.
3. Construction of 3 Nos. of head sluices.
4. Construction of 2 Nos. of Well syphon.
5. Construction of 3 Nos. of 1m drop.
6. Construction of 7 Nos. of cart track culvery and 2 Nos of B.T.culvert.
7. Improvement works for existing tanks and supply channel.

4. In the letter 2nd read above, the NABARD has approved the 12 irrigation schemes at a cost of Rs.4781.00 lakhs. Among these 12, the work of Excavation of Supply Channel from Viruppampatti Tank to Balethottam Tank and Four Other Tanks and One Pond in Pochampalli Taluk of Krishnagiri District for an amount of Rs.1.75 crore is also one of the schemes. NABARD has provided Rs. 166.25 lakh (95%) is the loan assistance and the balance amount of Rs. 8.75 lakh (5%) as state share.

5. The Government, after careful examination, decided to accept the proposal of the Chief Engineer (Plan Formulation), Water Resources Department and accord administrative sanction for the work of Excavation of Supply Channel from Viruppampatti Tank to Balethottam Tank and Four Other Tanks and One Pond in Pochampalli Taluk of Krishnagiri District at an estimated cost of Rs.1,75,00,000/- (Rupees One crore and Seventy five lakhs only) with NABARD loan assistance of Rs. 166.25 lakh (Rupees One crore sixty six lakh and twenty five thousand only) and with the state share of Rs.8.75 lakh (Rupees Eight lakh and seventy five thousand only) under RIDF XVII.

6. The expenditure towards the work sanctioned in para 5 above shall be debited in to the following new head of account, opened under Demand No.40.01:-

"4701- Capital Outlay on Major and Medium Irrigation – 03 Medium Irrigation - Commercial – 345 – Medium irrigation schemes – Schemes in the Eleventh Five Year Plan –II –State Plan- KE- Excavation of Supply Channel from Viruppampatti Tank to Balethottam Tank and Four Other Tanks and One Pond in Pochampalli Taluk of Krishnagiri District with Loan assistance from NABARD under RIDF XVII -16 Major works." (DPC 4701-03–345-KE-1600).

7. The Engineer-in-Chief, Water Resources Department is the Estimating, Reconciling and Controlling authority for the above new sub-head of account.

8. The Pay and Accounts Officer /Treasury Officers concerned are requested to open the above new Sub-Head of Account in their accounts.

9. The expenditure relates to the work sanctioned in para 5 above constitutes an item of "New Service" for which the approval of the Legislature will be obtained in due course. Pending approval of the legislature, initially this expenditure will be met

by drawal of advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG-I) Department separately. The Engineer-in-Chief, Water Resources Department, Chennai-5 is directed to send a proposal to Government in Finance (BG-I) Department in the prescribed format, along with a copy of this order for sanction of an advance from the Contingency Fund. Further, he is also requested to send necessary draft explanatory notes for the inclusion of the above expenditure in the Supplementary Estimates for the year 2011-2012 without fail at the appropriate stage.
