### **ORDER:**

The Hon'ble Minister (Public Works) while moving the Public Works Department Demand No.39 in the Tamil Nadu Legislative Assembly on 12.04.2022 has made the following announcement: -

"சைதாப்பேட்டை தாடண்டர் நகரில், 190 'சி' வகை அரசு அலுவலர்களுக்கான புதிய அடுக்குமாடி குடியிருப்பு ரூ.72.00 கோடி மதிப்பீட்டில் கட்டப்படும்."

2. Based on the above announcement made by the Hon'ble Minister (Public Works), the Engineer-in-Chief and Chief Engineer (General), Public Works Department in his letters read above has sent the Detailed Estimate for the work of Construction of New multi storeyed "C" Type Quarters (190 quarters) for Government staff at Todhunter Nagar, Saidapet, Chennai for an amount of Rs.99.98 crore and requested necessary Administrative and Financial Sanction of the Government.

3. After careful examination of the proposal of the Engineer-in-Chief and Chief Engineer (General), Public Works Department, the Government hereby accord Administrative Sanction for a sum of Rs.99,76,70,209/- for the Construction of New multi storeyed "C" Type Quarters (190 quarters) for Government staff at Todhunter Nagar, Saidapet, Chennai, in order to implement the announcement made by the Hon'ble Minister (Public Works). Further, Financial Sanction is accorded for a sum of Rs.10,00,00,000/- (Rupees Ten Crore only) for the financial year 2022-2023. The balance amount will be released in the subsequent financial years.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"4216 - Capital Outlay on Housing - 01- Government Residential Buildings – 106 – General Pool Accommodation – State's expenditure – JA - Public Works Department – Housing Scheme – 416 Major Works – 01. Major Works."

5. The expenditure sanctioned in para-3 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Engineer-in-Chief and Chief Engineer (General), Public Works Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. The Engineer-in-Chief and Chief Engineer (General), Public Works Department is also directed to send a draft explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2022-2023 to Finance (BG.I/PW.I) Department without fail.

6. The Engineer-in-Chief and Chief Engineer (General), Public Works Department, Chennai is authorized to incur the expenditure sanctioned in para 3 above.
