### ORDER:

In the Government Order read above, orders were issued according Administrative Sanction for the construction of 114 Bridge works at an estimated cost of Rs.33670.62 lakh with financial assistance from NABARD under Rural Infrastructure Development Fund (RIDF) XXVII for the year 2021-2022.

2. In the Letter second read above, the Commissioner of Rural Development and Panchayat Raj has sent a deletion proposal for 8 bridge works at an estimated cost of Rs.1195.87 Lakh and the same has been forwarded to NABARD.

3. In the Letter 3<sup>rd</sup> read above, the Commissioner of Rural Development and Panchayat Raj has stated that as on date, out of 113 bridge works, 3 bridges were completed. The balance 110 bridge works are in various stages of Progress. The Government had so far released an amount of Rs.15000.00 Lakh vide Government Order read above drawn from FMA 2021-22 and an expenditure of Rs.4416.78 Lakh has been made and necessary reimbursement claims have also been submitted to NABARD. The reimbursement claims for the balance amount of Rs.10583.22 Lakh will be submitted subsequently based on the progress.


