2. From the Director of Survey and Settlement Letter No.K1/742/2014 (SY) dated 18.02.2014.

ORDER:

The Hon'ble Minister for Finance and Public Works in the Budget Speech (2014-2015) in the Floor of Assembly on 13.02.2014 has delivered as follows:-

"Various sections of the District Collectorates across the State will be computerised during the year 2014-2015 so as to make public service delivery more effective. A new Online Land Records Management System will also be launched".

2) In continuation of the Budget Speech (2014-2015) of Hon'ble Minister for Finance and Public Works, the Director of Survey Settlement has sent proposal that, "web-based software for Online Patta Transfer and Management of Rural Land Records will be implemented on Pilot basis in Srirangam and Perambalur Taluks and later this will be extended to other Taluks in a phased manner".

3) The Director of Survey and Settlement has further stated that,

- Under the Computerisation of Land Records Programme, 'A' Register and Chitta have already been computerized. Presently, computerized Land Records of all Rural Areas are maintained and processed in a stand-alone manner in all Taluk Offices.

- In order to facilitate online management of Land records, Web-based software has been developed through National Informatics Centre (NIC).
- This software has been approved by the State Level Monitoring Committee (SLMC) of National Land Records Modernization Programme (NLRMP) on 19.12.2013.
- This software will facilitate landowners to apply for patta online and also to view complete details of Land Records and current status of their applications.

4) The Government after careful examination decided to implement the web-based Online Patta Transfer and Management of Rural Land Records System on a Pilot basis in Srirangam Taluk, Tiruchirappalli District and Perambalur Taluk, Perambalur District and later on to be extended to other Taluks in a phased manner.

5) The Director of Survey and Settlement is directed to take necessary steps towards the speedy implementation of web-based Online Patta Transfer and Management of Rural Land Records System on a Pilot basis in Srirangam Taluk, Tiruchirappalli District and Perambalur Taluk, Perambalur District.
