ORDER:

In the Government order 3rd read above, orders were issued for all Government offices to function with half the work force in a system of six-day working week with effect from 18.05.2020.

- 2. In its Standard Operating Procedures forth read above, the Government of India, Ministry of Health and Family Welfare dated 04.06.2020, have issued guidelines that cleaning and regular disinfection of work places should be ensured both in office premises and in common areas as preventive measures during the lock-down period.
- 3. To undertake comprehensive cleaning, sanitizing of all Government offices by adopting the guidelines of the Government of India, the Government direct that all Government offices be closed on second Saturdays for the purpose of carrying out disinfecting activities in a full fledged manner on the second Saturday and Sunday.

4. The above orders shall be followed scrupulously, until further orders.
