### **ORDER:**

In the letter fifth read above, the Commissioner of Rural Development and Panchayat Raj (i/c) has stated that Government of India have sanctioned 34380 houses under Indira Awaas Yojana 5% Special Project for THANE Cyclone affected region of Cuddalore (22707 houses) and Villupuram (11673 houses) for the year 2013-14 and released 1<sup>st</sup> instalment to the tune of Rs.59.60 Crore and Rs.30.64 Crore directly to the Districts concerned.

2. The Commissioner of Rural Development and Panchayat Raj (i/c) has also stated that the second installment proposal for Indira Awaas Yojana 5% Special Project for the year 2013-14 in respect of Villupuram District was sent to Government of India.

3. The Commissioner of Rural Development and Panchayat Raj (i/c) has further stated that the Government of India have modified fund release pattern by releasing its Central share to the Districts through State Government from the year 2014-15. Accordingly, Government of India have released Rs.3064.16 lakhs as 2<sup>nd</sup> instalment of Central share under Indira Awaas Yojana 5% Special Project for the year 2013-14 and Rs.122.566 lakhs as 2<sup>nd</sup> instalment of Administration cost to the State Government through Reserve Bank of India, Nagpur.
