ORDER:

In the Government order first read above, orders were issued for the construction of 20,000 green houses for the year 2016 - 2017 under the Chief Minister’s Solar Powered Green House Scheme (CMSPGHS) and detailed Guidelines were also issued for implementation of the Scheme.

2. In the Budget Speech 2017-2018, among others, the following announcement has been made:-

“under the Chief Minister’s Solar Powered Green House Scheme another 20,000 houses will be taken up for construction in 2017-18 at a cost of Rs. 420 Crore”.

3. Pursuant to the above announcement, the Director of Rural Development and Panchayat Raj has sent draft guidelines both in English and Tamil for approval and also requested the Government to issue necessary orders for the construction of 20,000 houses, under Chief Ministers Solar Powered Green House Scheme for the year 2017-18 at a cost of Rs.420 Crore.

4. After detailed examination of the proposal of the Director of Rural Development and Panchayat Raj, the Government have accepted the proposal of Director of Rural Development and Panchayat Raj and accord Administrative Sanction for the construction of 20,000 houses, under Chief Minister's Solar Powered Green House Scheme during 2017-18 with unit cost of Rs.2.10 lakhs. The Guidelines for the implementation of CMSPGHS for the year 2017-18 is annexed to this order.

5. This order issues with the concurrence of Finance Department vide it's U.O.No.30382/Fin(RD)/2017, dated 06.06.2017.
