ORDER:

In the meeting held on 06.04.2015 and 08.04.2015 under the Chairmanship of Hon'ble Chief Minister and on 13.04.2015 by the Hon'ble Ministers for Social Welfare and Nutritious Meal Programme Department, Higher Education Department and School Education Department with Nutritious Meal Workers Associations, Government have interalia deliberated and decided to permit the Anganwadi Workers/ Anganwadi Helpers on Voluntary Retirement with benefits as per the rules under medical grounds.

2. In the letter read above, the Director, Integrated Child Development Services Scheme has sent proposal stating that the Anganwadi Workers/Anganwadi Helpers who could not able to continue the service due to severe medical grounds and without pending any criminal/disciplinary procedures may be allowed to retire from service with eligible retirement benefits. As Anganwadi Workers and Anganwadi Helpers Association is also insisting this demand, the Director, Integrated Child Development Services Scheme has requested the Government to issue necessary orders.

3. After careful examination, Government permit Voluntary Retirement with benefits to the Anganwadi Workers/ Anganwadi Helpers under Integrated Child Development Services Scheme as per the rules subject to the following conditions as a special case.

- i. Attaining the age of 50 years or 20 years of qualifying service.
 - ii. Not involved in any civil/criminal cases.
 - iii. No pending action against the Anganwadi Workers /Helpers for shortcoming in their performance.
 - iv. Furnishing medical certificate obtained from Medical Board on their inability/illness.
4. The Director, Integrated Child Development Services Scheme is requested to place this order before ensuing State Empowered Programme Committee meeting and also requested to inform the same to Government of India since the Integrated Child Development Services Scheme is being implemented under Mission Mode.
5. The Director, Integrated Child Development Services Scheme is requested to send periodical report in this regard to Government if any in the format prescribed.
