ORDER:

In the Government Order 1st read above, Government have sanctioned a sum of ₹ 264.10 lakh @ ₹ 1,90,000 per project for 139 projects towards imparting training and other activities for Adolescent girls in the age group of 11-18 years under the Non-Supplementary Nutrition Programme of SABLA for the year 2014-2015 based on the 2nd instalment released by Government of India.

2. In the letter 2nd read above, the Director, Integrated Child Development Services Scheme has sent the proposal regarding the clarification/amendment clause sought for towards releasing of funds under 3 various Heads of Account to carry out the proposed activities and requested the Government to issue necessary amendment orders.
