#### **ORDER:-**

In the Government Order first read above, the Environment & Forest Department has issued orders for sanction of a sum of Rs.78.80 lakhs as additional funds out of total required fund of Rs.415.80 lakhs (Rupees four crores fifteen lakhs and eighty thousand only), for the provision of additional facilities in the Butterfly Park and Nakshatravanam in Upper Anaicut Reserve Forest, near Srirangam in Tiruchirapalli District during 2014-2015 and also mentioned that the balance amount of Rs.337.00 lakhs (Rupees three crores and thirty seven lakhs only) will be provided by the Tourism Culture & Religious Endowments Department to carry out the above works . Based on the above orders, the Environment & Forest Department has requested Tourism Culture & Religious Endowments Department to sanction a sum of Rs.3.37 crore from the Tourism Culture & Religious Endowments Department Funds to carry out the above works.

2. In the letter 2<sup>nd</sup> read above, the Principal Chief Conservator of Forest has furnished a proposal with breakup details for a sum of Rs.337.50 lakhs, for the provision of additional facilities in the Butterfly Park and Nakshatravanam in Upper Anaicut Reserve Forest, near Srirangam in Tiruchirapalli District. Environment & Forest Department after acceptance of the above proposal of the Principal Chief Conservator of Forest has forwarded the same to this department for further action.

3. In the letter 3<sup>rd</sup> read above, the Commissioner of Tourism has also recommended the above proposal of the Principal Chief Conservator of Forest and requested the Government to sanction a sum of

Rs.3.37 Crores, for the provision of additional facilities in the Butterfly Park and Nakshatravanam in Upper Anaicut Reserve Forest, near Srirangam in Tiruchirapalli District during the year 2014-2015.

4. The Government after careful consideration accept the proposal of the Commissioner of Tourism and issue the following orders: -

- i. Sanction is accorded to the Commissioner of Tourism for a sum of Rs.337.00 lakhs (Rupees three crores and thirty seven lakhs only), for the Development of additional facilities in Butterfly Park and Nakshatravanam, in Upper Anaicut Reserve Forest near Srirangam, in Tiruchirappalli District to carry out the following works: -

- ii. The Commissioner of Tourism is authorised to draw the amount of Rs.337.00 lakhs (Rupees three crores and thirty seven lakhs only), sanctioned at item (i) above and permitted to disburse the same to the Principal Chief Conservator of Forest and execute the Works through the District Forest Officer, Tiruchirappalli Division, Tiruchirapalli.
- iii. The Commissioner of Tourism is also permitted to constitute a Monitoring Committee, consisting of Higher Officials of Tourism Department, Forest Department and the Tiruchirapalli District Administration to monitor the works executed by the Forest Department and to send periodical report, every month through the Tourist Officer, Tiruchirapalli.

5. The amount sanctioned at para 4(i) above shall be debited under the following head of account:

"5452-Capital Outlay on Tourism-01-Tourist Infrastructure-101-Tourist Centres – Schemes in the Twelfth Five Year Plan – II State Plan – KV Improvement of basic facilities in Tourist Centres-16 Major Works"

6. The Commissioner of Tourism shall ensure that necessary arrangements are made in the area of the proposed works at Butterfly Park and Nakshatravanam, in Upper Anaicut Reserve Forest near Srirangam, in Tiruchirappalli District, to visibly indicate that the above works were carried out through "State Tourism Department Funds"
