The Government after careful examination accept the request of Managing Directors of all State Transport Undertakings and accord sanction for enhancement of Dearness Allowance from 100% to 107% with effect from 01-07-2014 to Managerial Cadre Officers / Administrative and Technical Supervisors and to the employees of State Transport Undertakings covered under 12(3) Wage Settlement, subject to the condition that the entire financial commitment likely to arise on account of enhancement of the Dearness Allowance should be borne by the State Transport Undertakings without seeking any financial assistance directly or indirectly from the Government.
