The Chief Executive Officer, National Institution for Transforming India, NITI Aayog, New Delhi, D. O. No. 1/37/2018-tpt, Dated. 01.06.2018, and 08.06.2018.

ORDER:-

In the reference read above, the Chief Executive Officer, National Institution for Transforming India, NITI Aayog, New Delhi has stated that India is deeply committed in its attempt to leapfrog the conventional mobility model and achieve a shared, connected and zero emission future through progressive policies and initiatives. Hon'ble Prime Minister has imparted a vision of formulating an inclusive policy on transformative mobility for India. The National Institution for Transforming India (NITI Aayog) the Government of India's think tank is spearheading this initiative. Mobility has the potential of becoming a growth engine for energizing economies and act as catalyst for creating multitudes of employment opportunities. A global mobility summit 'MOVE' is also being planned which would involve leaders from across the world, policymakers, key stakeholders, innovators and manufacturers coming together to take this dream forward. This is an opportunity to lead mobility revolution & identify solutions specific to address the Indian subcontinent. To meet these ambitious objectives, it is imperative for the States to come together to transform the mobility ecosystem of the country. With the guiding principle of co-operative federalism, the task force on transformative mobility in all the States and Union Territories of the country have been envisaged. Further, he has stated that NITI Aayog would be coordinating with various States to gather inputs from their respective task forces and provide them a platform for presenting their ideas at the summit. He has therefore requested to constitute a **State Level Task-Force on Mobility** for seeking valuable inputs and understanding state specific policy measures with key stakeholders.

2. The salient features of the Task Force on Mobility are as follows:-

Objective:

The objective of the task force would be to formulate a Mobility

Strategy for the State after due deliberation on strengths, opportunities and challenges lying therein. The idea is to adopt a consultative approach seeking inputs from key stakeholders from the State.

The Roll/Terms of Reference of the task force:

- i. The task force would be at the pivot of mobility revolution in the State. It would act as a think tank and co-ordinating body for all the mobility initiatives in the State. Along with this, it would align the efforts of Central and State Governments and provide feedback to Central Government of its various initiatives around mobility.
- ii. The initial responsibility of the State Task Force would be to list the challenges and innovative solutions through which different issues of mobility can be solved.
- iii. As India is a diverse country with every State having different mobility needs which are guided by the geography of the region, the size and spread of cities, towns and villages, the economic activities etc. The mobility strategy should focus all different modes of transport such as Roads, Rails, Waterways, Airways and the intermodal connectivity.
- iv. Technological solutions should be explored to address intermodal connectivity to offer seamless travel for passengers which is safe, user friendly and cost effective.
- v. The focus of the strategy should focus on sustainable modes of public transport, transport oriented planning, digitization, employment opportunities urban and rural mobility, environmental impact of transport and shared mobility aspects etc.
- vi. The Task Force may also examine and address any other issues which are important though not specifically spelt out in Terms of Reference. The Task Force may devise its own procedures for conducting its business/meetings/field visits/constitution of sub-groups etc.,
- vii. The Task Force will submit a report within six months of its constitution.
- viii. Any other matter connected thereto.

3. The Government after careful consideration of the request of the Chief Executive Officer, National Institution for Transforming India, NITI Aayog, New Delhi decided to constitute '**State Level Task-Force on Mobility**' under the Chairmanship of Chief Secretary to Government, Government of Tamil Nadu with the following members:-


