In Tamil Nadu Government Gazette Extraordinary No.83, dated 31.01.2022, an Act has been passed as follows:-

*3. Notwithstanding anything contained in any State law for the time being in force, any organization may request the Commission, in such form as may be prescribed, to recruit candidates for appointment to posts in that organisation.*

*Provided that no such request shall be made in respect of the post of Driver and the posts classified as Group D in the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.*

2. Under the circumstances stated in the reference 4<sup>th</sup> read above, the Government is accorded to permit the Managing Directors of all State Transport Undertakings (except Metropolitan Transport Corporation (Chennai) Limited, Chennai) to furnish the vacancy details of Assistant Manager (Legal) to Tamil Nadu
