ORDER:

viii) Budget allocation for the Schemes should be utilized within the Financial Year. Unspent amount should be surrendered to the Government account and proposal for realotment of surrendered amount may be sent to the Government thereafter.

3. The delegation of power to the Director for Welfare of the Differently Abled in the above said additional Schemes are came into effect from 2022-2023 onwards.


