ORDER:

In the Government Order first read above, the post of State Commissioner for Disabled was redesignated as State Commissioner for Differently Abled. In the Government Order second read above, orders were issued notifying the State Commissioner for Differently Abled as the State Commissioner for Persons with Disabilities for the purpose of the Rights of Persons with Disabilities Act, 2016. In the letter third read above, the State Commissioner for Differently Abled has stated that in rule 2(1) (iv) of the draft Tamil Nadu Rights of Persons with Disabilities Rules, 2018, it is defined that “Commissioner for Welfare of Differently Abled” means head of the department for Welfare of Differently Abled. Hence, he has requested to change the nomenclature of the State Commissioner for Differently Abled as “Commissioner for Welfare of the Differently Abled” and issue orders in this regard.
